Center for Women This program operates as a contract facility with the North Carolina Department of Public Safety It is a 30 bed work release facility for state female offenders who are within 3 years of a release date CCT is required to provide programs and services similar to those offered by NCDPS and has a goal to prepare these women for a successful transition back into the community Operated since 1987, this program has an average 87% success rate for women who transitioned back to the community and not rearrested within 2 years

LifeWorks!
