# What is the organization aiming to accomplish?

Reduced anxiety, stress, and fatigue. Improved self-esteem and confidence. Increased human connection

# What are the organization's key strategies for making this happen?

During treatments, Angels physically touch every patient they serve. Whether it be a hand massage or relaxing skin care treatment, our Angels provide touch, comfort and relief. In addition, our aromatherapy services help reduce nausea, stress and fatigue. \n\nDuring services, patients not only receive skin care and makeup application, but also training on how to recreate the effects after they leave the hospital. After receiving services, patients indicate that they feel better about their appearance with an emphasis that Lipstick Angels helped them to feel "transformed".\n\nLipstick Angels visits offer patients the opportunity to have a conversation with someone who isn't a caregiver or a healthcare provider. It provides a moment of respite from thinking about chemotherapy treatment and allows for a conversation about something other than their health. It also provides patients something exciting to discuss amongst each other, creating another level of connection even when Lipstick Angels are not present.

# What are the organization's capabilities for doing this?

Our staff and volunteers are licensed estheticians and make-up artists who have been specially trained in oncology-sensitive skincare. We pay special attention to both the physical and the emotional aspects of living with cancer.

# What have and haven't they accomplished so far?

In 2018, Lipstick Angels served approximately 3750 patients in programs located in Los Angeles, San Francisco, and New York City, a 56% increase from the 2400 patients served the previous year and a 134% increase from 2016 numbers. Each year, the number of patients Lipstick Angels reaches continues to increase at a rapid pace. We hope to continue to expand to different hospitals in our current regions as well as expand to other states.







- -The Office of Foreign Assets Control (OFAC) <u>Specially Designated Nationals (SDN) list</u> organizations that are owned or controlled by targeted individuals, groups, and entities, such as terrorists or narcotics traffickers. Their assets are blocked and U.S. persons are generally prohibited from dealing with them.
