Girls Create is a mentoring program for playwriting, fashion design and visual arts through which 6th to 10th grade girls learn aspects of these art forms in a unique way--we bring in professionals to teach, guest artists to share their expertise and mentors from the community to guide and encourage the girls in their own creativity. Each week-long program culminates in a final project, which we invite the community, including the girls' friends and family, to celebrate at a Friday Presentation.
