THE ORGANIZATION TRAINED AND PLACED 17 DOGS W/ DISABLED VETERANS AND HELD ITS 1ST REFRESHER CLASS FOR 7 VETERANS WHO PREVIOUSLY PARTICIPATED IN THE PROGRAM. 2 DOGS WASHED OUT OF THE PROGRAM FOR BAD BEHAVIOR, BUT WERE UTILIZED AS COMPANION DOGS OR FACILITY DOGS - NO DOGS WERE RETURNED TO A SHELTER. 14 DOGS REMAINED IN THE TRAINING PROGRAM AT 6/30/2022. THE BOARD DECIDED THAT THE CONTINUED USE OF THE THRILL HILL PROPERTY WAS NOT IN THE ORGANIZATION'S BEST INTEREST DUE TO HIGH HOLDING COSTS AND THE LONG DISTANCE FROM THE TRAINING CENTER.
