LARRY POTTRIDGE RETURNED AS THE EXECUTIVE DIRECTOR/DIRECTOR OF DEVELOPMENT AFTER A 22 MONTH LEAVE. LARRY HAS BEEN WITH VA DOGS SINCE MARCH 2015.
