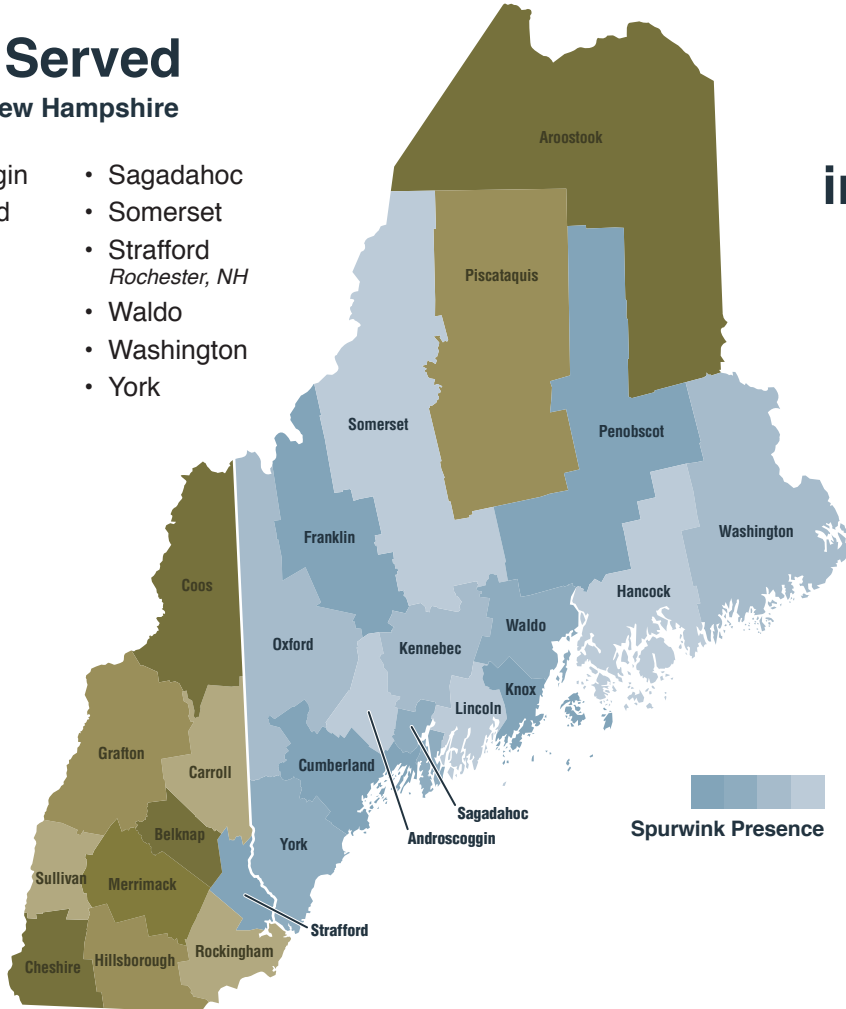

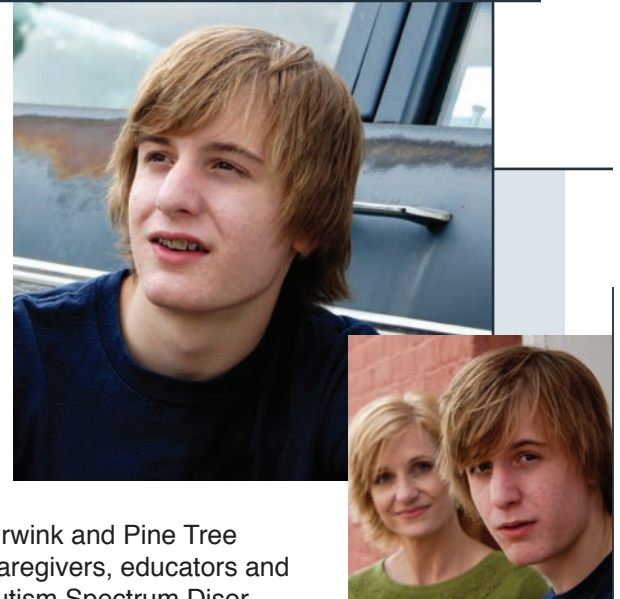
Today, Spurwink's footprint reaches 14 counties, serving over 4,750 children, adolescents, adults and families last year. The goals for 2014 reflect our commitment to excellence and the future of integrated behavioral healthcare:

1. Commitment to outcomes research, measures and analysis that informs best practices and allows us to examine the impact of our work and make significant improvements
2. Focus on innovative service development to thrive in the era of healthcare reform
3. Deepen and broaden our relationships in the community that lead to greater partnerships, increased awareness and ensure access to care



Highlights FY2013

- Beth Newlands Campbell was honored as Spurwink's 26th Humanitarian of the Year. Presented annually since 1987, the award recognizes an individual who shares Spurwink's commitment to improving the lives of others. The Dinner and Award Ceremony raised more than \$325,000 to support Spurwink's mission.
- Spurwink began implementing the CARE (Children and Residential Experiences) model throughout the agency in FY13. CARE is a trauma informed residential treatment model developed by Cornell University and is being used to guide decision making throughout Spurwink's day and residential treatment programs.
- The 5th Annual Southern Maine Autism Conference welcomed nearly 500 attendees in March 2013. Presented collaboratively by Spurwink and Pine Tree Society, the one-day conference is offered free of charge to parents, caregivers, educators and paraprofessionals who are living with and caring for loved ones with Autism Spectrum Disorders. Deb Lipsky, an adult living with autism, served as the keynote speaker.
- The Sprout Touring Film Festival features short films by, for, and about individuals with developmental disabilities. The films breakdown stereotypes while promoting acceptance of differences and awareness of similarities among us. By presenting films of artistry and intellect, the Sprout Film Festival hopes to reinforce accurate portrayals of people with developmental disabilities and expose the general public to important issues facing this population. Spurwink was pleased to bring Sprout to Maine in April 2013, with screenings in Portland, Lewiston, and Augusta.
- Project SHIFA (Supporting the Health of Immigrant Families and Adolescents), a Trauma Systems Therapy program for refugees developed by Boston Children's Hospital, continued to grow and thrive in Lewiston/Auburn, providing culturally appropriate behavioral health care for Somali youth and their families.

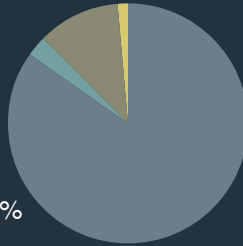

- Fundraising: 1.2%

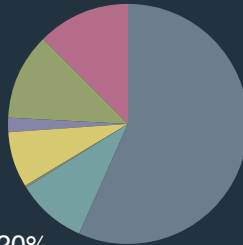


Expenses by Category
