RUEF grants help to facilitate educational digital videos and the development of robust social media platforms to distribute and amplify public education campaigns. In 2016, grant funds helped to produce more than forty new digital videos which accrued ten million views. Grants supported the development of volunteer education and training materials, online discussion forums, and peer-to-peer mentorship for more than seven thousand new, politically diverse volunteers across the nation. In addition, grants were used to develop a new "National On-Call" outreach program that allows volunteers to connect with Americans in every corner of the country to share information on democratic reform events and activities happening in their communities. Funds also supported in-depth policy research focused on issues of political corruption
