Coastal Ecology Program - The Coastal Ecology Program includes beach-wide planting efforts, species inventorying, and maintenance of multiple habitat types - from rocky intertidal to dunes to saltmarsh. One aspect of the Coastal Ecology Program is to protect the state and federally listed species on Duxbury Beach which includes two nesting bird species. DBR has an extensive and complex management, monitoring and reporting protection program with a goal to keep the beach open to people where possible while sticking to the rules that protect nesting birds.

Recreation and Beach Access - DBR strives to maintain recreational access to the beach when possible. Yearly road grading and repaving along with crossover repairs allow for safe recreation. The Reservation leases a large portion of the beach to the Town of Duxbury. Beach stickers are purchased from the Town for access to the parking lots and the outer beach for oversand vehicles. The Duxbury Police Department manages the people and vehicles on the beach. DBR hires a manager to operate the parking lot and food pavilion at the north end of the beach and receives a portion of the parking revenue. Mobility mats are installed on paths leading from the parking lot to the beach to allow more accessibility for those who live with conditions that limit their mobility.
