MARRIAGETEAM TRAINED AN ADDITIONAL 49 COACH COUPLES IN 2014 IN VANCOUVER WA AND MOBILE, AL. CLIENT EVALUATIONS CONTINUE TO SHOW EXCEPTIONAL RESULTS WITH 94% OF THE COUPLES WHO WERE CONSIDERING DIVORCE BEFORE COACHING NO LONGER CONSIDERING DIVORCE AFTER THEY COMPLETED COACHING. MARRIAGETEAM DID A MAJOR REWRITE OF ITS COACHING MATERIALS IN 2014. IT CONTINUED DEVELOPMENT OF A TRAIN THE TRAINER PROGRAM TO BUILD CAPACITY TO SERVE.
