IN JULY, WE MADE A DECISION TO OPEN A WELLNESS CLINIC FOR ANIMALS THAT HAVE BEEN ADOPTED FROM SPOKANIMAL. THIS IS AN ADDED SERVICE THAT WE PROVIDE FOR OUR ADOPTERS AND ALSO ALLOWS US TO ESTABLISH A RELATIONSHIP WITH THE FAMILY.
