In 201, Undies for Everyone distributed 1.62 million pairs of underwear. Over 1.4 million pairs were distributed to families affected by hurricanes Harvey, Maria, and Irma. Undies for Everyone also distributed 220,051 pairs of underwear to school nurses and area non-profits. School nurses in Dallas and Houston received 81,150 pairs at five hundred forty-one schools in eleven school districts, and non-profits (Houston Area Women's Center, City of Houston Back 2 School Fest, CPS, and the Houston Food Bank) received 38,901 pairs to be sent directly to disadvantaged children.
