School nurses in seventeen school districts in the Dallas and greater Houston areas received emergency underwear to serve children after an accident. Non-profit organizations including the Houston Area Women's Center, the City of Houston Back 2 School Fest, Bear (Be a Resource for CPS Kids), and the Houston Food Bank Backpack Buddies received 5-packs for distribution directly to disacvantaged children attending back-to-school events.
