PEI Kids works with the child, family, & caregiver to provide prevention, education and intervention programs on personal safety, sexual abuse, and the overall well-being of the child.

Programs including Comprehensive Juvenile Offenders Outreach Services, Managing Aggression and Violence, and the Lawrence Stationhouse Adjustment Project serve high risk youth and youth on probation for entry-level offenses using an evidence-based curriculum. Participants aged 11 through 17 receive violence prevention and conflict resolution skills, gang prevention and critical thinking skills, and training in respect for authority. The Council Against Youth Violence provides counseling and wrap-around services for

4b (Code: ) (Expenses \$ 230,716. including grants of \$ ) (Revenue \$ ) Crisis Intervention for Child Victims of Sexual Abuse - The only counseling program of its kind in Mercer County, this program has helped more than 6,000 children recover from the trauma of sexual abuse since 1987. The Mercer County Prosecutor's Office refers 95% of its reported child victims (approximately 200 each year) to PEI Kids. Since child sexual abuse adversely affects the entire family, therapeutic components include one-on-one counseling using TF-CBT for the child victim and support groups for child victims and supporting family members. PEI Kids also helps prepare victims for court appearances and provides transportation and court accompaniment as needed. PEI Kids charges no fees to program participants.

4c (Code: ) (Expenses \$ 133,164. including grants of \$ ) (Revenue \$ 51,807.) Prevention Education Workshops - PEI Kids' school-based primary prevention workshops teach and reinforce personal safety concepts to pre-school through tenth-grade students, school staff and parents through interactive, age-appropriate formats. As the NJ Child Assault Prevention designee for Mercer County since 1985, PEI Kids is well known throughout the area's public, private, and charter schools.
