THE LIBRARY PROVIDED ACCESS TO 143,568 ITEMS IN ITS COLLECTION, INCLUDING IN-HOUSE AND OUTREACH COLLECTIONS, FOR USE BY THE PUBLIC AT NO CHARGE. THESE ITEMS WERE BORROWED 175,159 TIMES. THE LIBRARY'S PUBLIC INTERNET ACCESS COMPUTERS AND PUBLIC WI-FI WAS USED 51,304 TIMES; THE ONLINE DATABASE WAS ACCESSED 51,128 TIMES; AND 4,169 REFERENCE QUESTIONS WERE ANSWERED.

THE LIBRARY OFFERED 768 ADULT AND CHILDREN'S PROGRAMS IN WHICH 5,477 CITIZENS ATTENDED. CONTINUED ON SCHEDULE O.
