The Northern Neck Food Bank provides supplemental food to over 8,000 people in the six counties of Lancaster, Northumberland, Richmond, Westmoreland, Middlesex and Essex. NNFB is the first rural food bank in the state of Virginia and was created to assist Feed More, Inc. (Central Virginia Food Bank) improve their service in this rural area. NNFB currently distributes over 898,000 meals annually.

NNFB is also one of the primary providers of farm fresh produce to food banks in eastern Virginia by distributing over 2.1 million servings of fresh produce to their six-county service area and food banks in Richmond, Norfolk and the Hampton Roads areas. In 2012, NNFB surveyed 87% of their

As a result of this finding, NNFB began the Northern Neck Agriculture program in partnership with several local farmers. The result was over 75 acres of crops either grown for the food bank or offered for gleaning (harvesting of non-marketable produce) and increased the amount of fresh produce distributed locally from 9% to 38% by the end of fiscal year 2014. The overwhelming success of this program allowed NNFB to send over 1 million servings of fresh produce to food banks across eastern Virginia.

During fiscal year 2014, the Northern Neck Food Bank increased their service area to include Essex County and all of Westmoreland County and increased fresh produce distributed by 40% and total distributed food by 30%.
