The Northern Neck Food Bank provides supplemental food to over 6,000 people in the six counties of Lancaster, Northumberland, Richmond, Westmoreland, Middlesex and Essex. NNFB is the first rural food bank in the state of Virginia and was created to assist Feed More, Inc. (Central Virginia Food Bank) improve their service in this rural area. NNFB currently distributes over 1,600,000 pounds of food annually.

NNFB is also one of the primary providers of farm fresh produce to food banks in eastern Virginia by distributing over 1,000,000 servings of fresh produce to our six-county service area and food bank in Richmond. In 2012, NNFB surveyed 87% of their clients regarding dietary health and found that 32% of all households receiving food from the food bank have a family
