The Northern Neck Food Bank provides supplemental food to over 12,000 people monthly in our six county territory of Lancaster, Northumberland, Richmond, Westmoreland, Middlesex and Essex, a 41% increase in the last year. NNFB currently distributes a record 2.1 million pounds of food annually to over 30 pantries and meal sites.

We currently offer the following programs to those in need in our region:

-Core distribution consists of delivering food (40% produce, 40% non-perishable, 10% meat and 10% bakery/dairy food items) to our partner pantries.

The Form 990 is reviewed by the President/CEO, the Treasurer of the Board, and the Organization's outsourced accountant. Any suggested edits/changes are discussed, and after all edits are made the return is filed.
