Commons was one of the first preschools in the U.S. to use the Reggio Emilia approach to educating young children, and has garnered regional and national recognition for our approach, results, and adaptations of the method. The Reggio Emilia approach is an educational philosophy that views the preschool years as crucial to the development of children as individuals. The program is based on principles of respect, responsibility, and community, and empowers

Chicago Commons Senior Services operates one adult day service center and provides in-home services for seniors and adults with disabilities.
