OUR CHILDREN LIVE IN TEMPORARY PLACEMENT FACILITIES, FOSTER HOMES, WITH RELATIVES, IN TREATMENT FACILITIES, OR HOSPITALS. BY PROVIDING THEM WITH A TRAINED CASA VOLUNTEER, A CASA CASE SUPERVISOR, AND A CASA STAFF ATTORNEY, JACKSON COUNTY CASA WORKS TO ENSURE EACH CHILD IS PLACED IN A SAFE, PERMANENT HOME AND RECEIVES APPROPRIATE EDUCATIONAL, MEDICAL, AND THERAPUETIC RESOURCES WHILE UNDER COURT JURISDICTION. THE OLDER FOSTER YOUTH PROGRAM HELPS TEENS, AGES 14 TO 21 AT RISK OF AGING OUT OF THE FOSTER CARE SYSTEM, DEVELOP PLANS FOR SUCCESSFUL INDEPENDENT LIVING.
