THE WORKFORCE DEVELOPMENT PROGRAMMING FOCUSES ON A CONNECTING EDUCATION AND CAREER PATHWAY DEVELOPMENT WITH GEORGIA'S WORK READY PROGRAM, AND PLACES IT IN AN INDUSTRY-FOCUSED CONTEXT LED BY AN INDUSTRY NETWORK.
