We engage participants with hands on programming with instructors in specific areas, and with volunteers in others. Through these programs our participants become embedded in the community sharing their talents and abilities while forging new relationships and friendships with people who might never be touched by or know this special needs group of people and what they have to offer. Our programming offers employment, business, social and life skills training; art; crafts; theater; music; yoga; fitness; reading and writing; science; nutrition; cooking; adaptive sports including skiing, snowshoeing, kayaking, and horseback riding; and two Special Olympic Teams featuring snowshoeing and skiing.
