This program has been funded by a grant from the Texas Department of State Health Services to provide services to qualifying members, by a United Way grant and charitable contributions.

4b (Code: ) (Expenses \$ 325,361. including grants of \$ ) (Revenue \$ ) The Young Adult Group program is a deep and wide lifetime recovery community for young adults ages 18-35 with peer counseling, mentorship, support groups and drug-free social activities for the entire family. The program was re-named during 2020 to better reflect age composition of the members.

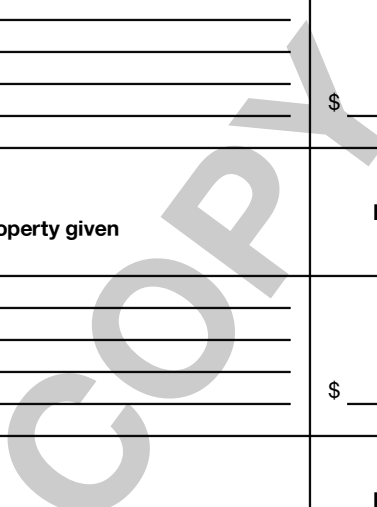

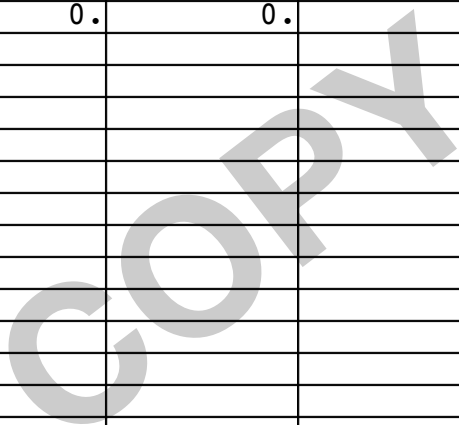
