Turner House Children's Clinic provides a full range of primary health care services to children 0-18: baby and well-child examinations, acute and chronic care, developmental screenings, hearing and vision screenings, immunizations, laboratory tests, lead tests, asthma education and management, medications, and referral to medical specialists. More than 4,000 children were seen in nearly 10,000 patient visits. Healthy Steps for Young Children is a national initiative focusing on the development of children 0-3 years. 281 families and 295 infants were seen by the Healthy Steps Specialist in 539 contacts. In addition, 92 postpartum depression screenings were completed and 361 referrals were made to other resources. The Reach Out and Read program promotes early literacy with children 6 months to age 5. Volunteers model techniques of reading aloud to children in the waiting room and give new books to children. Patients are accepted regardless of their ability to pay. All Spanish-speaking families have access to bilingual staff and an interpreter is available for physicians who don't speak Spanish. Volunteer Family Physicians, Pediatricians, and Nurse Practitioners provided 792 hours of care at a value of \$60,000.
