



Our work is powered by dedicated volunteers. These mental health advocates conduct our anti-stigma campaigns by sharing their lived experience with healthcare providers, business, government agencies, and the general public. NAMI Seattle family education helps parents and siblings to understand the diagnosis of a loved one. These classes also teach how to support them in navigating the mental health system in Washington State. Our efforts build community and let those affected by mental illness know they are not alone.

Direct Services - NAMI Seattle fills the gaps in our mental health system by providing support to those who do not know where to turn when confronted with a mental health challenge.
