We have hosted veterans with upper and lower limb amputations, complete and incomplete spinal cord injuries at varying levels, vision-impairment and blindness, as well as other serious injuries. To ensure a safe and enjoyable experience for all participants, each veteran is assigned a knowledgeable mentor during every event. We can accommodate most types of injuries and provide special adaptive equipment for veterans requiring additional help. During FY19, NPLB Outdoors hosted over 40 events across the United States for veterans and their families. These events included a wide variety of hunting and fishing activities, horseback riding adventures and other outdoors activities. Our organization builds lifelong relationships with veterans through fun outdoor activities with hopes of fostering a positive support network for everyone we serve.

Annually, board directors review their situation and sign an acknowledgement of no conflicts of interest. If a conflict exists, the governing body will work with the involved individual to ascertain all relevant facts concerning the conflict. If applicable, the conflicted individual will excuse himself or herself from voting on such matters.

Form 990, Part VI, Section B, Line 15 - Compensation of the President and other officers or key employees, is determined by the Board of Directors based on data obtained from various sources, including the 990 forms from comparable organizations and other industry sources. This is further reviewed by outside legal counsel. The finance committee also reviews and approves the overall compensation recommendations for the next fiscal year prior to its inclusion in the budget which is approved by the finance committee and the Board of Directors.
