IN 2019, WE SERVED 765 VOLUNTEERS THROUGH 1-TO-1 MATCH RELATIONSHIPS. WE MATCHED 208 CHILDREN WITH MENTORS, AN 18% INCREASE FROM 2018. WE ENROLLED 237 VOLUNTEERS WHO ON AVERAGE ARE MATCHED WITHIN 42 DAYS OF THEIR INTERVIEW. WE IMPLEMENTED LEAN PROCESSES WHICH HAS SHORTENED THE WAIT TIME MORE BOYS BY OVER 5 MONTHS. 87% OF CHILDREN ENROLLED ARE LOW INCOME. 88% OF CHILDREN ENROLLED ARE CHILDREN OF COLOR.
