Silk screening social enterprise: continued efforts to develop silk screening social enterprise to enable Rise Up Industries to have opportunities for Rise Up Industries members to receive job training and gain experience in a work environment. Rise Up Industries is still attempting to generate a sufficient volume of business to provide enough work to have Rise Up Industries members work in this social enterprise.

4b (Code:) (Expenses \$ 3,231 including grants of \$ 0) (Revenue \$ 3,420)
Tattoo removal services: we treated clients from County Probation, California Department of Rehabilitation, San Diego County Office of Education Work Readiness Program, and other non-profit organizations, such as Exodus Recovery, the Training Center, and Second Chance. In 2015 a total of 26 clients were served and 58 treatments were performed.

4c (Code:) (Expenses \$ 1,237 including grants of \$ 0) (Revenue \$ 2,056)
Coffee roasting social enterprise: continued development of coffee social enterprise to create opportunities for Rise Up Industries members to receive job training and gain experience in a work environment. Rise Up Industries has continued efforts to expand its customer base to generate enough volume of business to provide work for Rise Up Industries members. While Rise Up Industries continues to receive orders for coffee from individuals and some faith-based organizations, Major Market and Valley Farm Market are the only other outlets for sale of Rise Up Industries coffee.
