THE DEMAND FOR ENTRY INTO RISE UP INDUSTRIES JOB TRAINING PROGRAM AND SUPPORT SERVICES FAR EXCEEDS THE PROGRAM'S CAPACITY. 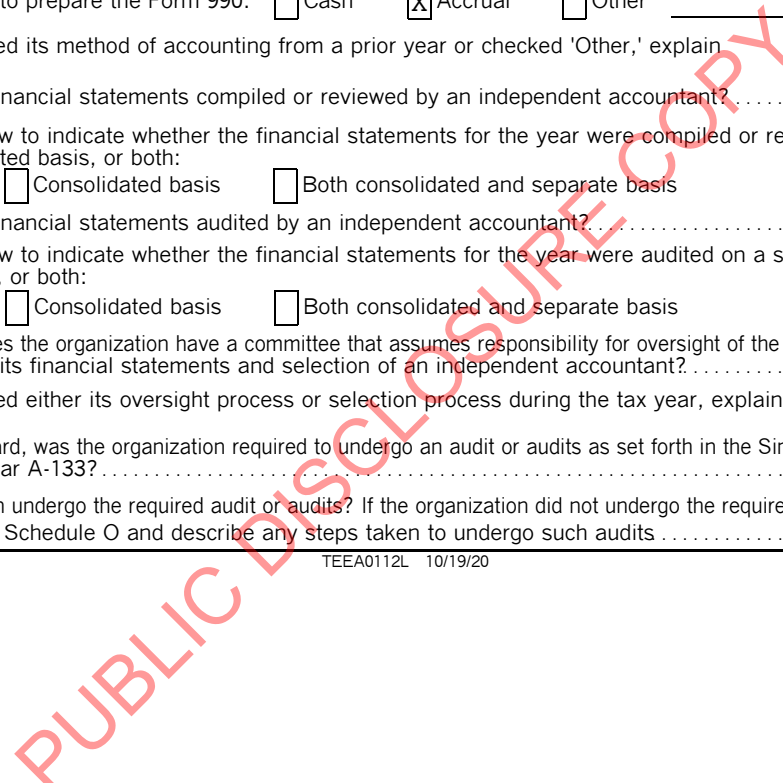

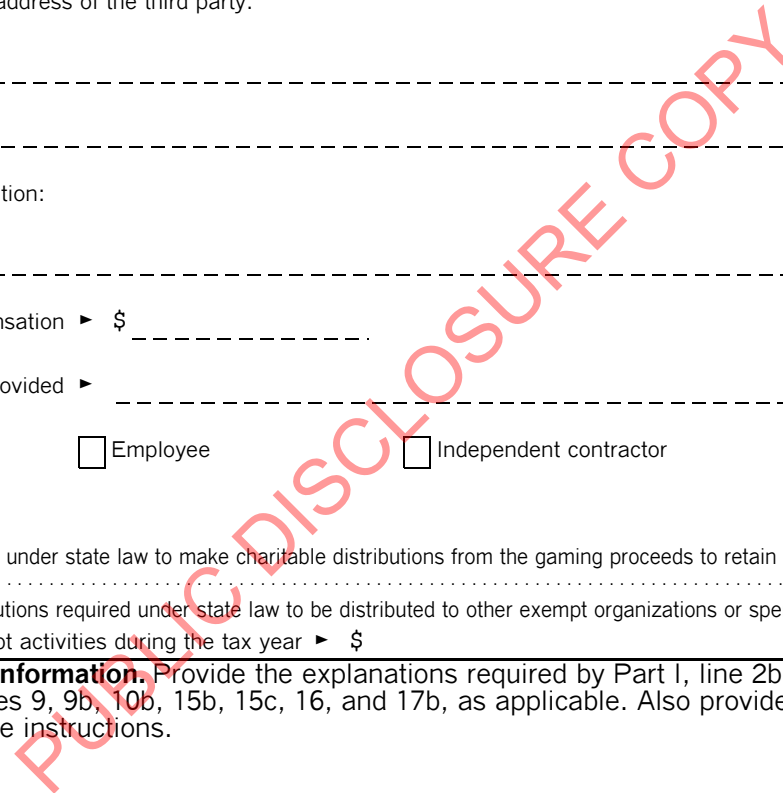
