

THE SUITCASES ARE PACKED BY VOLUNTEERS AT MERCY MALL AND EITHER DROPPED OFF ON EACH RELEASE DATE OR PICKED UP BY THE PROGRAM DIRECTOR. WE DON'T GET TO MEET THEM, BUT WE DO PRAY OVER THE SUITCASES AND THEIR JOURNEY TO A NEW BEGINNING. WE DISTRIBUTED 172 CASES OF HOPE IN 2019.
