PART OF THE SHOPPING EXPERIENCE IS MEETING THE INDIVIDUAL WHERE THEY ARE. WE ASK OUR CLIENTS TO FILL OUT A SHOPPING SHEET IN ORDER TO HELP US BETTER SERVE THEM. THE SHOPPING SHEET INCLUDES A LIST OF ALL THE INDIVIDUALS IN THE HOME AS WELL AS A PLACE TO LIST HOUSEWARES AND BABY ITEMS NEEDED.
