Service to the Poor & Mission Trips - By serving the poorest of the poor, Creatio aims to bring missionaries closer to seeing the face of Christ - thereby reconciling themselves to one another and to the Creator - as well as showing those who we serve that they are greatly loved. Throughout Creatio's history, we have completed over 35 successful mission trips across 7 different countries. Our projects include working alongside locals to provide housing, water, and community spaces; helping with relief efforts, such as the disastrous 2013 Philippines typhoon; providing spiritual and catechetical classes; and many others.
