THE GWINNETT COALITION MAINTAINS A CENTRALIZED DATABASE OF COMMUNITY RESOURCES AND OPERATES A HELPLINE, AN INFORMATION AND REFERRAL SERVICE, WHERE CALLERS RECEIVE FREE AND CONFIDENTIAL REFERRAL INFORMATION. NONPROFITS AND OTHER AGENCIES PROVIDING ESSENTIAL COMMUNITY RESOURCES ARE FEATURED IN THE DATABASE. TYPES OF SERVICES INCLUDE EMERGENCY SHELTER/HOUSING, RENT AND UTILITIES ASSISTANCE, EMERGENCY FOOD SUPPLY, MENTAL AND BEHAVIORAL HEALTH SUPPORT, SENIOR SERVICES, AND ACCESS TO HEALTHCARE, CHILDCARE, EMPLOYMENT OPPORTUNITIES, ETC.
