Our Forests Aren't Fuel (OFAF) Just a few years ago in the EU, biomass was largely considered a viable renewable energy option that would satisfy emissions reduction and renewable energy targets with relatively few impacts. Given the success of the Our Forests Aren't Fuel (OFAF) campaign and the efforts of our partners, the climate, forest and biodiversity impacts connected to flawed EU policies have been made visible and are now a key part of the public debate. This awareness is impacting policies and subsidies in the EU. Our efforts to engage citizens and raise issue awareness are also a key lever for continuing to exert pressure on the EPA and any potential domestic expansion of this industry. During 2016, Dogwood campaign staff organized citizen protests in local communities to See Form 990, Page 2, Part III, Line 4a (continued)

Wetland Forest Initiative (WFI) Wetland forests span nearly 25 million acres across nine states and are critical for community health and safety. They have some of the highest rates of biodiversity and carbon sequestration of any forest type in the US. In 2016, Dogwood Alliance laid out the beginning framework and strategy to develop an initiative to protect bottomland hardwood wetland forests. We proposed the formation of a conservation initiative to achieve large-scale protection. Significant progress has been made to develop the steering committee for the Wetland Forest Initiative. Staff have reached out to nearly 70 organizations and agencies to explore engagement on the steering committee for this initiative and have cultivated See Form 990, Page 2, Part III, Line 4b (continued)

Paper Campaign During 2016, Dogwood Alliance has maintained and expanded our work to improve forest management and environmental responsibility with forest product industry giants that collectively source tens of millions of tons of wood from the Southeast. Our work to push for new ways of mapping and supply chain management is having concrete outcomes for Endangered and High Conservation Value forests across millions of acres across the region. In addition, these new supply-chain controls are serving as success models and are positively influencing peer companies in the paper industry and translating to other regions in the West and globally.

stop facilities, led a comprehensive media strategy, engaged with a range of EU and US policy makers, developed a spectrum of key tools and resources, and, provided ongoing direct evidence linking industry actors to the clear-cutting of mature hardwood wetland forests. Our Forests Aren't Fuel elevated the voices of concerned citizens directly impacted by the growth in wood pellet exports. This exposure garnered sustained, high-level media coverage domestically and in Europe. The next few years still represents a critical window for action that can prevent the rapid expansion of an industry that has the potential to accelerate climate change and impact communities in the US and throughout the world.

On the defensive side of pushing back the threat, Dogwood is effectively mobilizing a diverse range of constituencies and organizing broad-based support to slow the growth trajectory of new biomass and wood pellet capacity. We are using this momentum to leverage stronger EU and US biomass policies and to begin to disrupt private investments in new capacity.

On the offensive side, we are working to build broad-based support for scaling up the protection of wetland forests throughout the region, as they are the ecologically important forests most at risk from the emerging trend of substituting wood for coal in power stations.

relationships with 40 organizations that either are serving on the leadership committee or want to engage as partners. Committees focused on strategy and communications, research, and governance and partnerships have been created and work plans have been developed. A Vision, Mission, and Platform was developed and approved, which serves as the basis of the Wetland Forest Initiative website and public engagement and endorsement efforts and was a focal point for the coalition's launch on World Wetlands Day, in 2017.

Dogwood also released a new report/brief entitled "Vanishing Treasures" that presents the case for protection and improved management of wetland forests in the US South. We also secured placement of an opinion piece on Huffington Post Green presenting the need for improved protections for this forest type.

With partners, we made significant headway towards spatially mapping the wetland forests throughout the South and beginning to quantify their ecosystem service values, with a geographic area encompasses 14 states and nearly 35 million acres. Conservation models are in process and will enable Dogwood to quantify the climate and community resilience benefits for varying preservation and new management approaches.

Over the course of the year, staff have presented about the need to be prioritizing protection and improved management for wetland forests at the Deforestation Forum in Washington DC in April, the Global Forest and Trade Network meeting in DC in March, the Environmental Paper Network meeting in San Francisco, and through engagement efforts in our International Day of Natural Disaster Reduction and placement of varying Op-Eds (including one from the mayor of South Miami).
