We piloted our ten-week Climate Change Curriculum at John F. Kennedy High School's (JFK) with their incoming 9th grade Leadership Training Institute cohort, which culminated with a modified Sustainability Challenge workshop as a final capstone. The purpose of the pilot was to demonstrate SGAP's abilities to implement a longitudinal in-school program and to assess the curriculum's effectiveness in engaging underserved students and advancing their knowledge in climate-related issues, environmental justice, and activism.
