Matan B'Seter does all of this while maintaining the anonymity of both its donors and aid-recipients. Self respect is thus maintained by the recipients and donors not knowing the identity of the other. Matan B'Seter refers to the highest form of outright charitable giving in the Jewish tradition as codified by Maimonides (literally "giving in secret").
