



June 30, 2012 Fiscal Year Annual Report

Our Mission: PET International seeks to reflect the love of Jesus Christ by bringing mobility and dignity to those in developing countries who are unable to walk. Our mission remained strong as we pursued our three main objectives: promotion of PET vehicles, coordinate PET production sites, and assist in the dissemination of vehicles to international agencies/sponsors. Promotion: Our Executive Director and others continue to promote the need for PET vehicles around the world. This was done in part by manning booths at events including Lions Clubs International Convention, Korean American Missions Health Conference, Global Missions Health Conference, and Technical Exchange for Christian Healthcare meeting to spread the word of PET's availability. Coordination with Affiliates: We continue to assist current shops and trained persons to advance their shops. The first team of persons from CA went to our training site in KS to prepare to become a production site. Our annual meeting was hosted by our Affiliate in KS. Three new Affiliates were approved in MN, IN and UT, for a total of 23 approved assembly sites around the world with more in the process of setting up shop.

Dissemination: Our Director of Operations' main task is seeking out new partners and coordinating the distribution of our PET carts. This includes working with trucking firms, growing number of partner NGOs, and international shipping companies. 5,863 PETs were manufactured (almost 1,000 more than 2011), and 5,247 PETs were distributed by all production sites. Because of our continued and long term partnership with some NGOs, they have now received multiple shipments whether to one or more countries or their staging warehouses.

Revenue

PET International, Inc. is a tax-exempt 501c3 nonprofit supported by those who believe in its mission of mobility. Financial support comes from individuals, secular and religious organizations and businesses. Many businesses provide discounts on PET building materials and supplies, and reduced rates on overland transportation and maritime shipping. Total revenue for fiscal year July 2011 to June 2012 was \$333,260. (Revenue included a large temporarily restricted gift.)

Expense

PET International paid its Director of Operations (DO), its only paid staff person, \$16,200 per year. Total expenses for the fiscal year July 2011 to June 2012, including the stipend to the DO, totaled \$132,477. Program expense (travel: program, presentation/booth costs, shipping, and reporting materials to tell the story and educate the public) was \$118,547 or 89%. Fundraising expense and Management & General expense (equipment, supplies, phone, travel: business, and office support: CPA review, payroll processing, etc.) was \$13,930 or 11%.

One of many reports received this year from our partner NGOs who distribute PETs.

"Dear Von Driggs, I appreciated so much your arranging for three PET carts to be loaded some time ago into a container at Samaritan's Purse destined for the Pioneer Christian Hospital at Impfondo, Republic of Congo. I spent the month of May this year at that hospital and worked part of the time with the leprosy patients who live at a residence in a village called Gangania, about five miles from Impfondo. One of the leprosy patients, Michel, is shown in the attached photo with his cart that means so much for his mobility. He is able to travel on his own from the lepers' residence to the hospital for his treatment. God bless you richly for this wonderful gift of transportation.

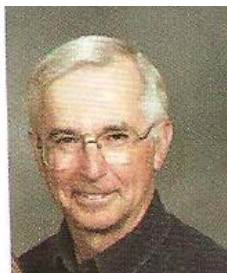
