Advancing the Science: MCBI assembled a special issue of Current: The Journal of Marine Education featuring "Ocean acidification: From ecological impacts to policy opportunities". MCBI funded awards to scientist-researchers to document ocean life before humans altered marine ecosystems, providing a poignant picture of what healthy oceans used to look like. MCBI organized five symposia as part of the International Marine Conservation Congress in May 2009.

4b (Code:) (Expenses \$ 1,738,395. including grants of \$ 210,850.) (Revenue \$ 18,250.) Protecting Marine Ecosystems: MCBI prepared scientific and policy analyses necessary to identify, nominate and advocate full protection for eight of the nine Pacific Islands sites designated by President Bush as marine national monuments on January 6, 2009. MCBI formed a Save our Seal Campaign network to help coordinate the non-governmental activities related to Hawaiian monk seal protection and recovery. MCBI organized three expert workshops to help build the Human Uses of the Ocean-California with NOAA's MPA Center. MCBI organized the first workshop on Surveillance and Enforcement of Remote Marine Areas. Throughout the latter half of 2009, MCBI worked with the Executive Branch to develop a comprehensive marine spatial planning framework for all US waters.
