Protecting Marine Ecosystems: To support efforts to identify valuable ocean ecosystems we developed information on global marine protected areas (MPAtlas.org) and an international database to house information on important places for the Secretariat of the Convention on Biological Diversity. We conducted field and modeling work to identify deep sea coral ecosystems.

To improve the conservation effectiveness of MPAs we hosted workshops on key topics and delivered recommendations to MPA managers. We led the marine and coastal conservation NGO community in developing and justifying funding recommendations for key ocean conservation programs, and provided scientific and policy expertise to discussions of marine spatial planning, deep sea fisheries, bottom trawling, protected areas,
